What is this product?

Type:

This is a UCITS Fund.

Term:

Open Ended Fund.

Objectives:

The Fund's primary objective is to provide Yield higher than the Blended Index and, secondarily, to grow the amount invested over the long-term.

The Fund seeks to achieve its objective through investing (under normal market conditions) at least 80% of its NAV in Equities and Debt Securities that are income producing, subject to at least 50% of its NAV being invested in common stocks.

The Fund may invest in securities of issuers located anywhere in the world, including issuers in developing or emerging markets (which may constitute more than 20% of NAV). Investments in Russian securities are limited to 10% of NAV.

The Investment Manager seeks to identify a portfolio of investments that will produce income and growth.

Investment decisions are based on U.S. and international economic

developments, outlooks for securities markets, interest rates and inflation, supply and demand for Debt Securities and Equities and analysis of specific issuers.

FDI are utilised for the purposes of hedging currency risk and investment purposes.

The Fund is actively managed and pursues a strategy to outperform a blended index comprised of 25% Bloomberg U.S. Aggregate Bond Index and 75% MSCI World Index.

Any income less expenses realised will be accumulated and reinvested into the NAV of the Fund.

Investors can buy or sell shares on any day on which banks in Dublin are open and the New York Stock Exchange is trading.

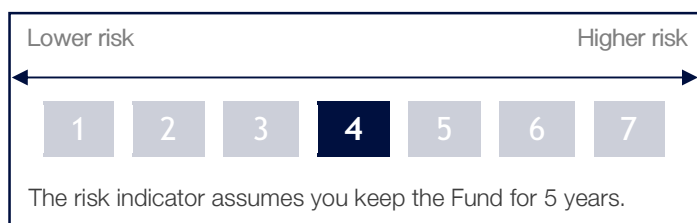

Intended retail investor:

This Fund is intended for investors seeking capital growth over a long-term horizon, with some current income, and who are prepared to accept a medium level of volatility from time to time.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the Fund for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this Fund compared to other products. It shows how likely it is that the Fund will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Fund as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact the value of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance scenarios

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the Fund and how well the Fund does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed, in the first year you would get back the amount that you invested (0% annual return). For the other holding period, we have assumed the Fund performs as shown in the moderate scenario and the investment is USD 10,000.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years
